



Ms. Erica had a guestion about the related services and at what point could she request a re-evaluation for her child. Mrs. Blair answered her guestions and asked if there were any additional questions or concerns. Then she moved to the next agenda item. Since none of the participants had questions about the special education process, services, goals, objectives, and related services after the explanation was given, Mrs. Blair moved on to the Special Education Compliant Protocol. She pulled up the link for the procedures, and then walked the committee through the process of filling out the complaint form, step-by-step. Next, the Disability Discrimination Complaint Procedures. Likewise, we went through the process of completing the form. Mrs. Blair explained that it is not required to utilize the online form; however, you must have all the components of the form when submitting a complaint. We then discussed the Discipline Policies and Procedures and pointed out where this information can be found in the student handbook as well. The committee took a 5-minute break and reconvened for Thanksgiving and Christmas plans. Ms. Dent and Mr. Brooks took the lead. They gave suggestions for the next school year, to have the students write "I am thankful for..." letters to someone in their family. We also discussed sensory bins, scavenger hunts, and cooking activities. Ms. Erica suggested for Christmas, we have the following activities: Cotton Ball Snowman, String of Lights Fingerprint Frame, Ice Cream Cone Christmas Trees, and Reindeer Snacks. Then, Mrs. Blair moved on to remind the participants about the application to apply and ways to spread the word. The meeting was adjourned at 2:40 PM.

There were no questions but the teachers and parents talked about the excitement experienced during the Thanksgiving and Christmas events. Mrs. Blair then moved to how to finish the school year strong. The teachers gave suggestions and Ms. Moliere asked if computer links for educational sites could be given out for the summer. Ms. Dent told the parents the students will have access to IXL and Reading A to Z. However, the students who are moving to 9th grade will lose their access in August. We then moved to Leap Connect and Regular Leap Test takers. The Leap Connect students completed their assessments but we talked about last-minute ways to help prepare the regular Leap tester for the upcoming state assessment. Mrs. Blair suggested having LEAP prep after-school camps starting early in the new school year. These camps will be designed to boost Leap scores for our inclusion students with special needs. All participants agreed that this is a great idea and we talked about ways to successfully implement this project. Next, Mrs. Blair discussed the LDOE parent survey. A survey was sent to every parent of our students with disabilities. Our ESYS discussion gave parents information about the start date, end date, times, and planned field trips. Lastly, Mrs. Blair reminded the committee to invite others to join our committee. The meeting was adjourned at 2:10 PM.
